



Terms of Use and Privacy Agreement

Adlibrio Ltd, is a UK Ltd Company whose mission is to make and distribute movies and literature. In order to finance our activities, we may from time to time embark on fund-raising activity, in which we may reach out to the public for donations.

1. Our Services

We are a commercial, profit-making company. We aim to bring productions to market in good time, however production times may vary according to prevalent conditions. These Terms of Use relate specifically and wholly to the proposed production of the movie 'Bunter's Brexit' and should not be interpreted as applying to other services of the Company.

2. No Warranty

The user acknowledges and agrees that the information provided on our services is on an "AS IS" basis. ADLIBRIO MAKES NO WARRANTIES, EXPRESS OR IMPLIED, WITH RESPECT TO THE INFORMATION AND HEREBY EXPRESSLY DISCLAIMS ANY AND ALL IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT SHALL ADLIBRIO BE LIABLE FOR ANY DIRECT, INDIRECT, SPECIAL, OR CONSEQUENTIAL DAMAGES IN CONNECTION WITH OR ARISING OUT OF THE PERFORMANCE OR USE OF ANY PORTION OF THE INFORMATION. Adlibrio does not represent or warrant that any product or business plans will be marketed or carried out as disclosed, or at all. Any actions taken by the user in response to the disclosure of the Information shall be solely at his/her risk.

3. Privacy Policy

We ask that you review the terms of our Privacy Policy, so that you are aware of how we collect and use your information. Our services may be used by people all over the world, personal information that we collect may be stored and processed in the United Kingdom or any other country in which we maintain facilities. By using our services, you consent to any such transfer of information outside your country.

4. Donations

Your donations will be wholly utilised to bring 'Bunter's Brexit – the Movie' into production and to cover distribution costs. This will include all direct and indirect overheads usually attributed to movie production.

Donations are non-refundable and do not imply a share of the company, a partnership or an affiliation of any kind, and furthermore do not affect the right of the company to exercise sole copyright over the website material and other IP related to 'Bunter's Brexit' in relation to the movie or the book.



5. Best Endeavour

Adlibrio will make best endeavour to bring 'Bunter's Brexit' to market, but cannot be held responsible if circumstances beyond its control prevent the completion of the production.

6. Benefits

Donations may include entitlement to certain benefits, such as premiere seating, appearance in credits, inclusion in casting. You understand that in the unlikely event that Adlibrio is unable to complete the production of the movie, then you waive these benefits unconditionally.

7. Information that we Collect

Personal Information, such as your name, contact details (such as address, phone number, email address, identification number on government-issued ID), financial information (such as bank account number), device details (such as IP address, web browser user-agent information), demographic details (such as gender or age)

We also collect or automatically receive some other information, such as:

- the web page that referred you to our donation pages;
- the amount you donated;
- which of our pages you request and visit;
- the date and time of each request you make to our donation pages;
- comments and suggestions from you;
- correspondence between you and Adlibrio;

8. Do not Track

Adlibrio is committed to protecting the information we collect from all of our donors. We do not share this information with third parties, except in the specific circumstances described in the "Sharing Donor Information" section of this policy. Because we protect all donors in this manner, we do not change our behaviour in response to a web browser's Do Not Track signal.

9. How we Use donor Information

We use Donor Information collected from you for general administrative purposes and to operate our fundraising processes. This includes:

- administering the Adlibrio Fundraising Services;
- updating you about upcoming fundraising and other Adlibrio activities;
- thanking you for your donation; and
- setting language preferences.



We also use Donor Information collected from you to comply with various obligations relating to recordkeeping and reporting. This includes:

- distributing donation receipts;
 - maintaining our internal records test features;
 - complying with applicable tax requirements;
 - reporting to applicable government agencies as required by applicable law; and
 - communicating substantive changes to this policy and related policies.
- We engage in the foregoing activities to comply with our legal obligations and for our legitimate interests in managing our donation processes.

Where processing is based on your consent, you may withdraw your consent at any time consistent with applicable law.

10. Password Security

If you register an account with us you are responsible for safeguarding your own password and should never disclose it to any third party.

11. Sharing Donor Information

We understand that donors may wish to remain anonymous, and we strive to honour such requests and preserve your anonymity. However, in limited circumstances, we use and share Donor Information in the situations and under the conditions described below. We will never sell, trade, or rent your non-public Personal Information.

With your permission. With your consent, we may share your information for a particular purpose. For example, we may give donors the option to have their name publicly associated with their donation.

In anonymized form. We may publish or share anonymized Donor Information. For example, we may share anonymized data sets to show donation trends. Comments and suggestions. We may publish any comments or suggestions that donors provide us, including in promotional materials, in anonymous form. In the rare instance that we do publish such information with donor attribution, we will do so only with your written (which may be electronic) consent.

Online payment processors. In order to facilitate online donations, we have partnered with payment processors. When you make a donation to Adlibrio through whether by credit card, debit card, or other methods of online payment, you transmit your payment data directly to the payment processor. We do our best to use contractual agreements and other mechanisms to help ensure that these processors maintain the confidentiality of your information. However, please be aware that Adlibrio is not responsible for the privacy practices of these processors;



please consult the privacy policies of the applicable payment processor for more information about its practices.

Other service providers. We use third-party service providers or contractors who assist with the organization and facilitation of our services, or who help run our fundraising operations or improve your experience with them. While we cannot ensure the privacy or security of services provided by third-party providers, we do our best to use contractual agreements and other mechanisms to help ensure that these service providers or contractors treat your information consistent with, and in a manner no less protective than, the principles of this policy.

For legal reasons. On certain rare occasions, consistent with our legitimate interest and/or to comply with our legal obligations, we may access, preserve, or disclose to public authorities or other persons your Personal Information if we reasonably believe it is necessary to satisfy a valid and legally enforceable warrant, subpoena, court order, law or regulation, or other judicial or administrative order. If we believe that a particular request for disclosure of a donor's information is legally invalid or an abuse of the legal system, and the affected donor does not intend to oppose the disclosure themselves, we will do our best to fight the request. Adlibrio is committed to notifying you via email at least ten (10) calendar days, when possible, before we disclose your personal information in response to a legal demand. However, we may only be able to provide notice if we are not legally restrained from contacting you, there is no credible threat to bodily harm that is created or increased by notifying you of the request, and you have provided us with an email address or other current contact information.

Nothing in this policy is intended to limit any legal objections or defences you may have to a third party's request (whether it be civil, criminal, or governmental) to disclose your information. We recommend seeking the advice of legal counsel immediately if such a request is made involving you.

12. How we Protect your Information

To ensure a high level of security and confidentiality, Adlibrio employs a variety of physical, administrative, and technical measures, policies, and procedures to help protect your personal and financial information from unauthorized access, use, alteration, disclosure, or destruction. However, you should be aware that no storage system or data transmission is 100% secure. Therefore, we cannot guarantee that our security protocols will not be compromised.
